- We consider any work shorter than 35 minutes to be a "short."
- Foreign language work must be dubbed or subtitled in English.
- In addition to your entry, please enclose any press kits, reviews, or publicity materials.
- Eligible shorts must have been completed after January 1, 2009.
- **PLEASE do not put stickers on your DVD submissions – and PLEASE take the time to make sure the DVDs play.**
